(For all students in the Program)

## Undergraduate Minor Program in Business

Any undergraduate students who are not pursuing a degree program in the business discipline (See note 1) with (i) a CGA of 2.5 or above, and (ii) either a grade B or above in LANG 1001/LANG 1028 (prior to 2012-13)/LANG 1049 (prior to 2012-13)/LAGR 2080; or a grade B- in LANG 1003, or a grade C+ or above in LANG 101 (prior to 2011-12)/LANG 102 (prior to 2011-12), may enroll in this minor program. They must declare their intention to enroll in the minor program during the application period conducted in around June every year. Students who wish to withdraw from the minor program should apply before the last day of add/drop period in the first regular term of their final year of study.

The Minor Program in Business requires a minimum of 6 courses ( 18 credits) to be taken from the following courses:

Notes:
(1) Except for students pursuing a degree program in the School of Business and Management, Dual Degree Program in Technology and Management, BSc in Mathematics -Mathematical Sciences Option in Business and Management, BSc in Mathematics and Economics, and BSc in Risk Management and Business Intelligence, all other undergraduate students are eligible to apply for the Minor Program.
(2) Of the 6 courses ( 18 credits), at least 4 courses must be taken from the list of Business Fundamental Electives:
ACCT 2010, ECON 2103/ECON 2113/ECON 2123/ECON 2913*, FINA 2203/FINA 2303, ISOM 2010, ISOM 2700, MARK 2120 and MGMT 1110/MGMT 2110.

No more than one course within the same course groups of ECON 2103/ECON 2113/ECON 2123/ECON 2913, FINA 2203/FINA 2303, and MGMT 1110/ MGMT 2110 may be counted towards the elective requirement.

* ECON 2913 is only offered for students under the 3-year degree.
(3) A maximum of two courses from the following list of Business Advanced Electives can be counted towards the Minor Program requirements:
ACCT 2200, ACCT 3030, ACCT 4410, ECON 3014, ECON 3024, ECON 3334, FINA 3104, FINA 3204, FINA 3304, ISOM 2400 (for students admitted to the University prior to 2012-13), ISOM 3310, ISOM 3360, ISOM 3710, ISOM 4020, ISOM 4740, ISOM 4750, MARK 3410, MARK 3480, MARK 4450, MGMT 1120 (for students admitted to the University prior to 2012-13), MGMT 3110, MGMT 3120 and MGMT 4210.

Students are allowed to reuse a maximum of 9 credits from courses that they have taken to fulfill their program requirements and out of these 9 credits, courses reused for the Common Core should not more than 6 credits. For credit transfer, students can transfer a maximum of 2 courses to the minor program.

To graduate with a minor in Business, the students must be enrolled in the minor program, complete all of its requirements, as well as all the requirements of their major program, and attain an average grade point of at least 1.85 in courses taken within the minor program.
